- 1) We have obtained the necessary information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;
- 2) In our opinion, proper books of accounts have been kept by the Society so far as appears from our examination. However there are several discrepancies in the maintenance of ledger accounts. (Loan Accounts were not being maintained in a proper manner and maintenance of ledger balances of members needs improvement);
- 3) The Balance Sheet and Income & Expenditure account referred to in this report are in agreement with the books of accounts:
- 4) In our opinion and to the best of our information and according to the explanations given to us, the said statement of accounts together with our report of even date, give the information required by law, in the manner so required, and give a true and fair view:
 - a. In the case of the Balance Sheet, of the state of Affairs of the Society as at 31st March, 2020:
 - b. In the case of Income & Expenditure account, of the Income for the year ended on that date.
- 5. We further state that in our opinion the Balance Sheet is in accordance with the provisions of the Reserve Bank of India and Society has been following the provisions of the Banking Regulations Act, 1949.

PART-A

Previous Audit Report

The previous Audit report was discussed. As stated to us, the society has striven to remove some of the discrepancies and has submitted the compliance report to the registrar of Co-operative Societies in respect of the previous audit report.

- 1. Documents of loans are being filled up properly and completely in general and no loan is outstanding for more than 5 years.
- Society is granting loans (limited to installments paid) to member after they have repaid a few installments to take care of their emergencies. Differential loans are paid even when loan limit is revised upward.
- 3. Society is contemplating strict compliance of surety.
- 4. The membership register and the share allotment register are being completed.
- Society intends to write share certificate numbers on the passbook of the members to overcome the problem of affixing seal on the share certificates and their issuance to the members.



SECTION-1

A. MANAGEMENT

Managing Committee:

The list of the Members is annexed herewith.

General Body Meeting:

No GBM was held during the year under audit. The last GBM was held on 23.03.2017

Managing Committee Meetings:

As per the Minute Books of the Managing Committee 15 meetings were held during the year.

Registration File:

We were informed that the society has maintained a separate Registration file containing the latest Co-operative Societies Act, Rules and Other Regulations and a copy of the Bye-Laws of the society together with all the registered amendments to the Bye-laws. The file was produced before us.

B. MEMBERSHIP:

No. of members as on 31.03.2020 : 195
No. of members as on 31.03.2019 : 206
Members admitted during the period : 11
Members left during the period : 22

The list of members as on 31-03-2020, list of members admitted during the period and the list of members left are attached herewith.

Membership Register:

The Membership Register produced for our verification was incomplete. The record of all the members are not entered and all the columns were not filled up e.g. columns pertaining to the date of admission as well as those pertaining to the date of registration in the case of past member were not filled up. However a new register is started from 01.04.1994 which incorporates particulars about new members herewith.

Other Comments:

 The approval of the General Body should be obtained for new enrollments as well as resigned members and information sent to the registrar of the Societies office.

2. Membership Application Register which is important and primary record should be introduced and be regularly maintained.

- 3. As explained to us the membership fee together with the amount of qualifying shares and the amount of deposit if any, is being received from the persons desirous of becoming members on the date of application itself i.e. without their application being approved by managing Committee. This is very much undesirable and is in contravention of the provisions of the Delhi Co-operative Societies Act. and Rules and the Bye-laws of the societies.
- 4. Keeping in view the problem of share allotment register, share certificates and common seal thereon, the society intends to write share certificate number on the pass books of the members.

Co-operative Education Fund:

There is Rs. 36,170/- in the amount as on 31.03.2020. (Previous Year - Rs. 37,400 as on 31.03.2019)

Interest Payable to members: Rs. Nil as on 31.03.2020.(Previous year Rs.nil as on 31.03.2019)

Interest is payable to members @6.6% p.a. on the deposits received from them. The details of deposits as under:

Dividend Payable: Rs. 378,785/-

A sum of Rs. 378,785/- has been debited to P&L A/c during the year on account of dividend @9.6% on the Share Money for the year 2019-20. A sum Rs. 378,785/- for the year 2018-19 and balance provision is Rs. Nil.

Meeting Expenses payable: Rs. Nil/-

A sum of Rs. Nil was paid as meeting fees and nothing was outstanding for the year 2019-20 and also a sum of Rs. Nil outstanding for the year 2018-19, which was paid during the year Audit Fees Payable: RS. 25,960/-

A sum of Rs. 25,960/- was paid as audit fee for the year 2019-20 and the 2018-19 as against an audit fee of Rs. 97,240/-.

Honorarium Payable: RS Nil/-

A sum of Rs. 177,500/- was paid as honorarium during the year and nothing remains unpaid.

Observations:

- It was observed that the society is following the practice of receiving applications for loan, but the loan applications are not being filled up completely by the members. Of late the documents of loans are being filled up in a better manner and no loan is outstanding for more than 5 years.
- It was observed that society has granted fresh loans (limited to installment paid) to the members, after they have re-paid a few installments to take care of their emergencies.
- 3. State Bank of India is situated within CRRI PREMISES where all members are maintaining their saving accounts. The salaries of members are credited to their A/C's every month. It is suggested that the loans be disbursed maximum twice a month and the list of borrowing members bearing A/C no.(s) and Loan amount/ Interest/ Dividend be sent to bank for crediting their A/Cs. Use of cheques for disbursing loan be maximized and no cash loans be given at all. Payment of loans in cash be deposited by the respective member in society's Bank A/C and the counterfoil of pay in slip be given to the society to get receipt from the society. This step is to discourage repayment in cash and avoid incidents of duplicate notes.
- 4. The list of dues to and from members is attached along with the report.
- 5. It was observed that the limits as laid down by clause 41 of Bye-laws of the society pertaining to the commitments of a member as surety were not being enforced by the society. Clause 41 of the Bye-laws fixes the upper limits of a member's commitment as surety at a amount equal to his maximum credit limits. Cases were observed where a member's commitments as surety were more than three times his maximum credit limit. However four new surety register have been introduces for effective control and follow up,

Interest Receivable from Members:

A sum of Rs. 92,222/- was receivable on account of interest @12% p.a. on the loans advances to members as on 31.03.2020 and 131,233/- as on 31.03.2019.

Cash in Hand:

Cash in hand as on 31.03.2020 was Rs. 5,554/-as against Rs. 3,144/- as on 31.03.2019 confirmation certificate attached.

State Bank of India C/A:

The balances as per the bank statement and bank book as 31.03.2020 was Rs. 38,91,729/-.

Interest on C.D. & O.D. A/C:

A sum of Rs. 6,86,059/- (including Rs. 6,86,059/- paid) and nil been accounted as interest on compulsory deposit and optional deposit respectively, during the year and a sum of Rs.

7,17,420/- (Including Rs. 7,17,420/- paid) and Rs. 123/- being accounted as interest on compulsory and optional deposit respectively.

Typing Printing and Stationery:

A sum of Rs. nil has been incurred on typing, printing and stationery as against a sum of Rs. nil/- incurred in the year.

Honorarium:

A sum of Rs. 2,13,000/- has been paid provided as honorarium as compared to Rs. 1,77,500/- in last year.

Bank Charges:

A sum of Rs. 649/- has been debited as bank charges as compared to Rs. 737.50/- in last year.

Refreshment, Posting and conveyance Expenses:

A sum of Rs. 13,750, nil, and 3,625/- were spent during the year as against Rs. nil, nil, and Rs. nil/- spent on refreshment, postage and conveyance in last year.

Meeting Expenses:

A sum of Rs. nil/- has been spent/ proposed to be spent in Meeting/General Body Meeting as against Rs. nil/- being spent/ proposed last year.

Interest on Loans:

During the year a sum of Rs. 14,11,874/- was collectable as interest on loans to members and a sum of Rs. nil/- was collectable as interest on loans to members in last year.

Admission Fee:

A sum of Rs. 110/- was collectable as entry fee from new members as against a sum of Rs. 90/- collected in last year.

Other Observations:

a. Profit & loss A/C as on 31.03.2020 shows the balance of Rs. 2,67,699/- which represents the total distributable funds available to the society. Apportions during the year have been made by transferring nil to Reserve Fund A/C. Previous year figures have been regrouped/ rearranged wheresoever considered necessary.

 The provisions of Rules 70 of the Delhi Co-operative Societies Rules Maintenance of Liquid Resources and Distribution of Assets have not been complied with by the Society.

- c. The Provisions of Rule 82 of the Delhi Co-operative Societies Rules 1973 regarding "Use of Reserve Fund in the business have not been adhered to by the society. However the reserve fund to the tune of Rs. 31,47,032.73/- is a serious violation.
- d. Society should open Saving Bank A/C instead of present Current A/C to earn interest Optional Deposit should be avoided when funds available.
- e. Society should file annual income tax return and comply with tax audit requirements.

We are thankful to Sh. Narender, of the Society for their Co-operation that enabled us to complete the audit in time.
